His experience also included securities disclosure, corporate and board governance, board recruiting, activist shareholder relations, executive compensation, compliance, U.K. and U.S. regulatory affairs, government relations, privacy, ethics, intellectual property, capital projects, internal and external government investigations. Additionally, he supervised internal audit, the insurance fraud investigation unit, facilities, real estate, and human resources.

From 2001 to 2003, Mr. Glick was Deputy General Counsel at Bank One Corporation (now JPMorganChase), leading 24 lawyers who advised the bank's largest line of business and its technology group, and working with the bank's federal regulators -- OCC, FDIC, and the Federal Reserve.

Mr. Glick's prior law firm experience concentrated on financial and corporate litigation, including high profile, multi-jurisdictional matters -- hostile takeovers, proxy fights, consumer fraud class actions, director liability claims, SEC investigations, securities class actions and shareholder derivative claims at Skadden, Arps, Slate, Meagher & Flom and then at Hedlund, Hanley & John, a 23-lawyer corporate litigation boutique.

His international experience includes work with companies and regulators in Japan, the United Kingdom, Switzerland, Germany, France, the European Union, and Canada.
